The processing to which the data will be subjected and the purpose thereof is as follows:

RELATIONSHIP WITH CUSTOMERS/SUPPLIERS/CONTRACTORS

- ✓ Perform analysis, evaluations, and selection, along with subsequent acceptance or decline of a potential business relationship.
- ✓ Request proposals and quotes.
- ✓ To share business agreements for the acquisition of goods or services.
- ✓ To analyze, evaluate, and consult the information provided by the Owner in lists for the control of money laundering and domestic or foreign terrorist financing; binding and non-binding, this consultation is extended to shareholders as natural persons.
- ✓ Statistical analysis, referencing, consultation of public databases, verification, and audits.
- ✓ The company may collect information about commercial relationships with other entities, consult financial data at credit bureaus that manage financial information databases, and collect data required to manage the contractual or commercial relationship with the Owner.
- ✓ To certify the commercial relationships generated between the parties.
- ✓ To make phone calls, send emails, conduct verification visits, send communications, and verify references.
- ✓ To send information about our products and invite them to participate in providing their services or purchasing products.
- ✓ To perform analyses on the quality and levels of service received from suppliers and/or contractors.
- ✓ For legal compliance in tax, customs, and commercial matters with administrative, judicial, and police entities.
- ✓ To carry out administrative procedures (accounting, financial, updating of personal data).
- ✓ To be transmitted and/or transferred to business partners, affiliates, subsidiaries, parent companies, allied companies, franchises, or other data controllers located inside or outside the country.
- ✓ Use in communication, dissemination, and promotion campaigns for products, activities, or services.
- ✓ Carry out, through any means, either directly or through third parties, programming and provision of technical services, sales, purchases, billing, portfolio management, monitoring product performance, collection, business intelligence, marketing activities, promotion or advertising, service improvement, collection monitoring, verification, consultation and control, enabling payment methods, as well as any other activities related to our current and future products and services, for the fulfillment of contractual obligations and the corporate purpose of the company.
- ✓ Request proof of authorization granted by the data subject, except when expressly exempted as a requirement for processing (Article 10 of Law 1581 of 2012).
- ✓ File complaints with the Superintendency of Industry and Commerce for violations of the provisions of Law 1581 of 2012, after consulting with or submitting a request to the Company.
- ✓ Be informed by PLASTICOS ESPECIALES S.A.S or the data processor, upon request, regarding the use that it has made of your Personal Data.
- ✓ To carry out, through any means, directly or through third parties, programming and provision of technical services, sales, purchases, billing, portfolio management, performance monitoring, etc.
- ✓ Revoke the Authorization and/or request the Deletion of data when the Processing does not respect constitutional and legal principles, rights, and guarantees..
- ✓ Access, free of charge, your Personal Data that is being Processed by PLASTICOS ESPECIALES S.A.S. The Company acknowledges that the personal data found in its Databases
- ✓ Revoke the Authorization and/or request the Deletion of the data when the principles, rights, and constitutional and legal guarantees are not respected in the Processing.
- ✓ Access, free of charge, your Personal Data that is being Processed by PLASTICOS ESPECIALES S.A.S.
